Note:

1. In order to successfully apply, please carefully read through each rule of this guide book.
2. Documents of the application shall be uploaded and submitted by **5 p.m. on November 5th (Friday)**. Application received after the deadline will not be processed.
3. Please make sure that you know every date of the application, or you may be late for the deadlines.
4. According to Personal Data Protection Act, YunTech will collect, process or use personal data of applicants under the purpose of admissions or related works. The students who have applied will be considered as agree YunTech to use your personal data for admission affairs, registration or data building for enrolling.
5. According to Article 13 of Gender Equity Education Act, Educational institutions conducting recruitment or giving approvals for admission are not permitted to treat any prospective student differently on the basis of their gender, gender traits, gender identity, or sexual orientation. Educational institutions, classes and curricula that receive approval from the competent authority on the basis of their having a specific historical tradition, or some particular educational objective(s), or other reasonable grounds which do not include any gender-related element(s) are not subject to this restriction. Applicants who have situation against to this law during the process of applying, please provide the related facts and contents to our Admission Committee in two weeks.

Application Instructions

1. Eligibility

Applicants should comply with MOE Regulations Regarding International Students Undertaking Studies in Taiwan.

(1) Nationality

International students shall be confined to as an individual who does not hold Republic of China (Taiwan) nationality, who has never held Republic of China (Taiwan) nationality nor has an overseas Chinese student status.

Note:

Individuals who are holding foreign nationalities and have stayed abroad for more than 6 years (till February 1st, 2022) and who are qualified for one of the following situations are considered as international students.

1. Individuals holding both foreign and R.O.C. nationalities but have never had the household registration in Taiwan are considered as international students.
2. Individuals holding foreign nationality and once had R.O.C. nationality but have not had household registration issued by Ministry of Interior for at least 8 years (till February 1st, 2022) are considered as international students.
3. The above individuals who have never held overseas Chinese student status and studied in Taiwan nor have received a student status by University Entrance Committee for Overseas Chinese in the enrollment year.
4. Individuals who are not limited by the mentioned rules are students who are recommended by governments, organizations or schools and approved by the mentioned institutions, and have never had Republic of China (Taiwan) household registration.

(2) Education Background

International students who graduate from a senior high school, college, or university which are recognized by Taiwan Ministry of Education are allowed to apply for the admission.

1. Students with bachelor degrees are eligible to apply for graduate studies in Master Programs at YunTech.
2. Students with master degrees are eligible to apply for graduate studies in Ph.D. Programs at YunTech.

2. Time of Enrollment: February, 2022.

3. Study Period

(1) Master Degree: 1-4 years

(2) Ph.D Degree: 2-7 years

4. How to Apply

Note: Applications are rejected when documents are incomplete or handwriting on application papers cannot be read.

(2) Application Deadlines

- From September 15th to November 5th, 2021
- Application received after the deadline will not be processed.

5. Required Documents

- (1) Online Application Form
- (2) Deposition
- (3) Letter of authority
- (4) Verification of nationality
- (5) Original copy of applicant's certified diploma which is notarized by R.O.C. (Taiwan) Embassy, Representative Office, Economic and Cultural Office or other organizations authorize by Ministry of Foreign Affairs. Official academic records from applicants' secondary schools or colleges/universities. If the original languages of academic records are neither in English nor Chinese, the applicants shall submit academic records either in English or Chinese.

(YunTech has the right to ask for certified documents from R.O.C. (Taiwan) overseas offices if needed.)

Note:

- i. If the original diploma is neither in English nor Chinese, a translation copy in English or Chinese which is notarized by R.O.C. (Taiwan) overseas offices is required.
 - ii. After receiving the admission letter the following documents should be notarized by one of the following organizations; R.O.C. (Taiwan) Embassy, Representative Office, Economic and Cultural Office or other organizations authorize by Ministry of Foreign Affairs. The diploma, transcript of grades and financial support statement.
- (6) Financial Support statement
The financial support statement shall be notarized by R.O.C. (Taiwan) Embassy or be sent directly by applicants' banks: a financial statement issued by a financial institution within the past three months (the equivalent of at least NT\$150,000 or US\$5,000 annually. Financial support statements from banks of Taiwan are not required to be notarized.

(It should prove the financial sufficiency to support the applicant's study at YunTech.)
 - (7) Autobiography within 1000 words

- (8) A Chinese or English study plan
- (9) Two letters of recommendation.
- (10) Language Proficiency (e.g. TOEFL, TOEIC, HSK, CPT, etc.)
- (11) Certifications of capabilities
- (12) Individuals holding foreign nationality and holding or once had R.O.C. nationality shall submit the certificate to prove he/she have stayed abroad continually (more than 6 years while applying)
- (13) Individuals holding a foreign nationality and once had R.O.C. nationality but have never had household registration in Taiwan shall submit certificate issued by Ministry of Interior to prove his/her stay for more than 8 years.
- (14) Application fee: NT\$1000 or US\$40

The application fee should be remitted to YunTech bank account (Remittance fees should pay by applicants), or pay the fee in cash at International Corner, YunTech. Please enclose a copy of Bank Telegram Transfer receipt along with the other documents.

6. Important Reminders

- (1) Applicants should make sure if they are qualified by checking all criteria from the department of enrollment.
- (2) Applicants who apply the department which courses are mainly taught in Mandarin should take related language courses at their own expense if they do not have a language certification.
- (3) International students who have been forced to drop out at any institution in Taiwan due to behavior problems, failed academic performances and criminal records are not allowed to apply for admission. Should any of the above violation cases be verified, the applicant's student status will be revoked immediately.
- (4) International students who have the household registration, naturalization or restoration to R.O.C. nationality during your study have to lose your international students status and accept the discontinuation of your study by the University.

- (5) According to regulation issued by Taiwan Ministry of Education, applicants should present YunTech a valid medical insurance of 6 months started from the date of entering Taiwan.
- (6) International students that are eligible to study at YunTech can apply for the Tuition Waiver and monthly stipend (please tick the selection from the application form.) Steering Committee for Internationalization will select the qualified students. Guidelines of National Yunlin University of Science and Technology Scholarship for International Students is attached.
- a. Types and amount for scholarship:
 - Full-funded Stipend: full tuition waiver and monthly stipend up to 15,000 NTD for PhD and 10,000 NTD for Master students
 - Partial-funded Stipend: full tuition waiver and monthly stipend up to 8,000 NTD for PhD and 6,000 NTD for Master students
 - tuition waivers: waiver for full tuition, waiver for half tuition, and waiver for a quarter of the tuition.
 - b. The duration of the scholarship is one year, and the applicants must re-apply yearly. The maximum years of applying and receiving scholarship is as the following.
 - Master students: 2 years, and 1 year for dual degree students
 - Doctoral students: 3 years, and 2 years for dual degree students
 - c. Applicants can't be granted the scholarship if you meet the following conditions.
 - The project students selected by your government which have the agreement with Ministry of Education of Taiwan can also apply for tuition waiver or monthly stipend.
 - Applicants already receives Taiwan scholarships from our government or get the financial support from local government.
 - Applicants can't apply for the scholarship if you are double registered students in Taiwan
 - Applicants can't apply for the scholarship if you are a full-time worker and receive the monthly salary in Taiwan. But it doesn't apply to this condition if applicants get financial aids by assisting school affairs.
- (7) The contact information of applicants should be accurate. Applicants that are unable to reply to notification and enquiries from YunTech before deadline will be regarded as giving up their application.
- (8) Applicants, in accordance with the provisions of the Personal Data Protection Law, allow YunTech to hold and keep their personal information for the usage of applying and enrollment in YunTech. YunTech will have the obligation and responsibility to keep applicants' personal informational for the use of enrollment evaluation only.

3. Adopt fee criteria as business department—other departments except fees in engineering.
4. The dormitory fee for Building D2 is 11,188 NTD per semester (extra cleaning fee, 450NTD, should be paid) and fee for building G is 11,280 NTD (extra cleaning fee, 300NTD, should be paid).
5. Based on the regulation from Ministry of Education, Taiwan (No. 1000108296), published on June 29th 2011, the tuition for Taiwan Fellowship receivers who are from the countries with diplomatic relations with Taiwan are the same with Taiwanese students.
6. Students who do an internship in another organization off campus for an entire academic year should pay the Tuition and 80% of Basic Tuition.
7. Students who would like to apply for the dorm should notice the deposit will be not returnable if you withdraw, even not moving in, as liquidated damages.
8. Students who receive tuition waivers still need to pay dormitory fees, usage fees for computers and network communication, language learning fees(except for 4-year program and Department of Applied Foreign Languages), and insurances of students.
9. All prices are calculated and charged in NTD. Prices mentioned in USD are for reference use only.

(2) Living Cost

The estimated living cost at YunTech is about NT\$130,000 per year, including accommodations, transportation and other personal expenses.

(3) Other Expense

It's around NTD\$8,000 for some applications, such as ARC, National Health Insurance, Health Checkup, and Bank Account...etc after being admitted and registered into school.

(4) Medical Treatment and National Health Insurance (NHI)

- i. Overseas Chinese Insurance: International Students who stay in Taiwan for less than 6 months (NTD3,000/6months)
- ii. National Health Insurance: International Students who have been living in Taiwan for over 6 months (NTD826/month)

Note:

- i. Division of International Students from Office of International Affairs of YunTech can assist international students' living in YunTech
 - ii. International students have priority to stay in campus accommodations for the first academic year.
 - iii. The rates of tuition are subjectively to change annually.
- *Anything unmentioned here shall follow in accordance to the relevant regulations of YunTech.
- *If there should be any discrepancy or contradiction between the English and Chinese version, the Chinese version will apply.

Guidelines of National Yunlin University of Science and Technology Scholarship for International Students

Approved on May 2, 2017 by the Administrative Assembly.

Amendments were approved on October 23, 2018 by the Administrative Assembly.

Amendments were approved on April 23, 2019 by the Administrative Assembly.

- I.** National Yunlin University of Science and Technology (hereafter referred to as YunTech) has formulated this set of Guidelines for the express purpose of drawing outstanding international degree-seeking students to YunTech and rewarding international degree-seeking students who behave well during semesters.
- II.** Application requirements:
 1. Incoming international students: Degree-seeking applicants (including dual degrees system), who apply to YunTech according to *Regulations Regarding International Students Undertaking Studies in Taiwan*, with high school, bachelor or master degrees may apply for the scholarship through admission application. The required forms are including application form, deposition, transcripts of the current highest academic degree, recommendation letters, health certificate and certificate of language proficiency.
 2. Current students: International degree-seeking students with YunTech academic status who achieved behavior score above 80 may apply for the scholarship during the post period. The required documents include an application form, deposition, transcript of the last two semesters, research result, recommendation letter from advisor and the certificate of Chinese course taken in last year (2 credits as minimum for each semester). All the documents should be sent to Office of International Affairs (hereafter referred to as OIA).
 3. Applicants can't be granted the scholarship if they meet the following conditions.
 - i. Applicants who applied to YunTech through the project from Ministry of Education of R.O.C.
 - ii. Applicants already received scholarships from Taiwan government institutions, or awards issued by YunTech entities.
 - iii. Applicants can't apply for the scholarship if they are double registered students in Taiwan.
 - iv. Applicants can't apply for the scholarship if they are full-time workers and receive monthly salary in Taiwan. But this condition doesn't apply to applicants who get financial aid by assisting school affairs.
- III.** Types and amount for scholarship:
 1. Full-funded Stipend: full tuition waiver and monthly stipend up to 15,000 NTD for PhD and 10,000 NTD for Master students.
 2. Partial-funded Stipend: full tuition waiver and monthly stipend up to 8,000 NTD

for PhD and 6,000 NTD for Master students.

3. Tuition waivers: waiver for full tuition, waiver for half tuition, and waiver for a quarter of the tuition.

IV. The duration of the scholarship is one year, and the applicants must re-apply annually. The maximum years of applying and receiving scholarship are as the following.

1. Undergraduate students: 4 years, and 2 years for dual degree students
2. Master students: 2 years, and 1 year for dual degree students
3. PhD students: 3 years, and 2 years for dual degree students
4. Undergraduate and master students who direct pursue PhD Degree: 4 years

V. Scholarship source: The department or thesis advisor must provide the scholarship recipients at least 50% of the full amount for both full-funded stipend and partial-funded stipend, and the remaining portion of the stipend provided by the university.

VI. The number of the scholarship awarded for a given year depends on the amount of YunTech funding available that year. The information will be posted on the application guide.

VII. Verification method

1. Incoming international students: Attach the required documents listed at point **II** (application requirements). The process will be verified by the Department and OIA, and reviewed by the International Affairs Review Committee.
2. Current students: Attach the required documents listed at point **II** (application requirements). The process will be verified and recommended by the Department and the College, and reviewed by the International Affairs Review Committee.

VIII. Grant & revoke

1. If applicants meet any of the following matters, the qualification of the scholarship will be revoked.
 - i. Applicants didn't get the recommendation from the Department or the applications didn't meet the standards of OIA.
 - ii. Suspension or withdrawal.
 - iii. Applicants haven't taken a leave of absence from school or dropped out of school, yet literally suspend the studying.
 - iv. Applicants didn't finish registering in the current semester.
 - v. Leaving Taiwan for more than one month.
 - vi. If the learning situation is not good, that is, if the score of a subject is less than 71, it will be reported to the International Affairs Review Committee to consider whether it will be suspended.
 - vii. Applicants violated the laws of the R.O.C.

- viii. Applicants who got one minor demerit by YunTech.
 - 2. After the reason for the above suspension is eliminated, the recipient can resume the scholarship upon approval of superiors in the period of the award. The original award cannot be extended.
- IX. Applicants should declare all the required documents are valid, otherwise YunTech has the authority to cancel the application, and all previously awarded amounts must be returned to YunTech.**
- X. These Guidelines have been approved by Administrative Assembly. They were put into effect after approval by the university president. Later amendments will follow the same procedure.**
